- 8. An internal committee will review and evaluate all eligible submissions after the close of the contest on July 1, 2015. Submissions received after July 1, 2015 will not be considered for the Book Writing Contest.
- 9. One (1) winner will be selected from all eligible submissions. The winning submission will be illustrated with contestant's name as "author" and then added as the 1,000th book in the n2v librarv.
- 10. n2y will notify the winning entrant by August 1, 2015.
- 11. No purchase is necessary to win and purchasing n2y products will not increase one's chances of winning.
