4. All submissions must include a title and name of author.
5. Only one (1) submission will be permitted per author.
6. All submissions must be accompanied by a signed Copyright Assignment (see below).
7. All submissions must be sent to [travis@n2y.com](mailto:travis@n2y.com) no later than July 1, 2015.
8. An internal committee will review and evaluate all eligible submissions after the close of the contest on July 1, 2015. Submissions received after July 1, 2015 will not be considered for the Book Writing Contest.
9. One (1) winner will be selected from all eligible submissions. The winning submission will be illustrated with contestant's name as "author" and then added as the 1,000<sup>th</sup> book in the n2y library.
10. n2y will notify the winning entrant by August 1, 2015.
